

Without active participation, empowerment programs struggle to operate effectively, often leading to initiatives that lack meaningful outcomes (Dushkova & Ivlieva, 2024).

Another major challenge lies in organizational management. Effective management is crucial for organizations like LPM, yet Bojong Menteng encounters several issues in this regard. The ambiguous organizational structure and poor internal communication negatively impact the organization's performance (Visser, 2000). 
