Citing the latest research results and actual market data will provide a sound basis to support the claims and arguments presented in the article.
3. Exploring Methodology: This article states that this research is a literature study but does not explain further the methodology used. It is important to explain how the literature was selected, the inclusion and exclusion criteria, and why previous theories and research were selected. This will increase the reader's confidence in the validity of the research.
4. Clearer Presentation of Information: Several sentences in this abstract feel ambiguous and difficult to understand. It is recommended to formulate these sentences more clearly and concisely. Make sure that the reader easily understands the ideas and arguments conveyed.
5. Use of More Specific Keywords: The keywords presented are still too general and not specific enough for the context of this study. It is suggested to consider using more specific keywords that reflect this research's main topic and contribution in the context of investment and the pandemic.
