Reviewer #1:

1. This paper has some interesting information, and the topic is quite important; however, it seems that some essential points indicate deficiencies in data collection (questionnaires), thus making the conclusions questionable.
2. The approach to using English is poorly understood, so as a first step, a firm editorial hand is needed to figure out what to rethink.
3. The literature review refers to engaging experience and studies elsewhere, but it is not well linked to the research and, therefore, the conclusions.
4. The focus of this paper is more based on Indonesia alone. What if taken from another country?
5. There should be more information about the object of research, not only about the content of the study.

I hope you can make improvements as soon as possible and send the revised article again via this email.
